SCREENING STATUS AGAINST ARIES NOTICE DATED 13TH FEBRUARY, 2026

1. The status of representations received against Notice no. ARIES/Estt./2025-26/1391 dated 13th February, 2026 has been updated in the Institute's website.
2. Utmost care has been taken while preparing the list. However, the candidature of applicants found eligible with reference to ARIES Notice No. ARIES/Estt./2025-26/1391 dated 13th February, 2026, the present list, and in accordance with Point No. 3 of the General Terms and Conditions of Advertisement No. ARIES/Estt./2025-26/646 dated 29th August, 2025, is purely provisional and does not confer any right to employment or selection. If, at any stage, it is found that any information furnished by a candidate is incorrect, false, misleading, or essential qualification/document are not submitted, or if any material information has been suppressed or overlooked by the Institute, the candidature of such candidate shall be cancelled forthwith without any further notice at any stage of recruitment.
3. Now, No Further representations/communication shall be entertained in this regard through any mode.
4. Information regarding the syllabus has been updated on the Institute's website. The written test will be of 50 marks in bilingual (Hindi & English), except language paper, will be made for all the posts.
5. In order to qualify for the skill tests, the minimum cut-off marks in written examination for the post reserved for SC/ST category would be 50 percent and the cut-off marks for others would be 55 percent. However, maximum of 10 candidates against each post will be called for the skill test. The skill test will be of a qualifying nature. Any other information i.e. Date of exam and venue shall be provided at a later stage, candidates are advised to visit the Institute website regularly for updates. The same shall also be conveyed to eligible candidates by their registered mail.
6. The recruitment for the post of Junior Officer and Administrative Assistant shall be subject to the decision of Hon'ble High Court, Nainital Uttarakhand against writ petition No. WPSS-1041/2021.
